



**HOPEWELL TOWNSHIP OF THE BOARD OF SUPERVISORS
CUMBERLAND COUNTY, PA
Regular Meeting Minutes – March 04, 2024**

The Board of Supervisors of Hopewell Township met on March 04, 2024 at 7:00pm. The Meeting was opened with the Pledge of Allegiance. Chairman announced that the meeting would be recorded.

Present: Tyler Gamble, John Cover, Dave Elliott, Haileigh Diehl, Jamie Kensinger, Sean Shultz

Public Comment: None

Old Business: Dave made a motion to approve the minutes from the meeting on February 21, 2024. John seconded. Motion carried.

Reports:

Treasurer Report: Jamie stated that revenue since February 22, 2024 was \$3,495.90. The total expenses were \$51,524.86. This resulted in a total revenue of -\$48,058.95. The three highest expenses were EMC Insurance Companies at \$39,334.00 which would be payment for the entire year, Citizens Bank at \$ 5,431.76, and ATA Security Systems at \$1,670.00. Dave made a motion to approve the revenue and expenditures. John seconded. Motion carried.

Zoning/Permits Report: Dave stated that there were 3 Zoning/Land Use Permits since February 22, 2024.

Shippensburg EMS: Beth Eiselman stated they had 17 calls in Hopewell Township for February and a total of 387 calls. For the year they had 27 calls in Hopewell Township and a total of 796 calls.

New Business: Sue Heberlig stated the Planning Commission met on February 15 for the Alsbaugh Subdivision. They recommend approval of all waiver requests. Those were the preliminary plan requirement, the drawing scale requirement, and the requirement to install sidewalk. The plan does have a note that the sidewalk would be installed in the future at the request of the township if it develops to that point but for now, it is not required. Dave asked if the sidewalk would be brought out to the existing homes. Sue said if the sidewalk starts going in that direction, then it would connect. Mike Wadel stated they would be responsible for their frontage. Sue stated there was a driveway application and the planning commission recommended approval with the condition that the wetland delineation is shown, DEP approves the sewage, and the driveway agreement as discussed. Dave made a motion to approve the subdivision with the waiver requirements. John seconded. Motion carried.

Dave made a motion to advertise the fertilizer lawn treatment bids in the March 7th edition of The News-Chronicle for the park. John seconded. Motion carried.
